

PERMITS-REQUIRED CONFINED SPACE CLASSIFICATION FORM

Use this form to temporarily reclassify a permitted confined space to a permit confined space which is only valid for the duration of work being performed and for no more than 8 hours. The space cannot contain any actual or potential atmospheric, physical, or chemical hazards within the space must be eliminated without entry into the space.
